Organizational Reform and Personnel Appointments at Akebono Brake

In addition to the organizational reforms and personnel appointments dated 1 January and 1 February of this year, Akebono Brake will target the further reinforcement of its organizational structure in order to ensure attainment of its new "Global 30" mid-term management plan commencing April 2005, through the following affiliated group management reforms effective as of 1 April 2005.

Key features of the organizational reform and personnel appointments

- Clarification of responsibility and authority through the abolition of the executive officer system at affiliated group companies.
- Changes resulting from the establishment of new companies.
 - ➤ Changes as a result of the commencement of business proper at Akebono Brake Hanyu Manufacturing Co., Ltd., and APS Corporation, both established on 25 March, and at Akebono Brake Sanyo Manufacturing Co., Ltd., established on 1 April.
- With the Purchasing Department composed of three groups (Planning Group, Purchasing Group and CATI Purchasing Group), specialization for expert operations is achieved through the clarification of roles and responsibilities.
