## **Akebono Brake Realigns Japan Production Network**

**TOKYO** – Akebono Brake Industry Co., Ltd. ("Akebono") announced a decision to realign its manufacturing operations in Japan, mainly in the Eastern region, as part of its efforts to achieve its Global-30 mid-term management plan.

#### 1. Reason for realignment

Akebono faces an increasingly challenging business environment in Japan due to lower automotive production, as Japanese automotive manufacturers shift production abroad to keep apace with globalization. To succeed in the current business environment of fierce global competition, Akebono must strengthen and reinforce coordination among its Japanese, US, European and Asian businesses, and build a foundation to expand sales worldwide. The Akebono Group will act as one to dramatically reduce costs and comprehensively strengthen global cost competitiveness. As a first step to accelerate this globalization, Akebono will effectively utilize and concentrate its managerial resources by realigning its Japan manufacturing operations, which play a central and leading role in the Group. The realignment is expected to build a sound business foundation that can lower prices, expand global sales, and withstand cost competition.

The production realignment will be done as follows.

A capital investment of approximately 4.5 billion yen is planned for a 2 year period from fiscal 2007 to the end of March 2009 to expand the Akebono Brake Fukushima Manufacturing Co., Ltd. plant and facilitate other aspects of the realignment. Under the new framework, Akebono will strengthen the competitiveness of its Japan business, which is expected to face intensified competition, and optimize managerial resources by recalibrating production capacity and equipment.

#### 3. Impact on financial results

The realignment is expected to take 2 years to implement and therefore a slight effect on the results for fiscal 2007 is expected.

## 4. Employees

Currently a new casting foundry is under construction in Tatebayashi City, Gunma Prefecture. The foundry is expected to begin operations in April 2008. Akebono will proceed to discuss employment conditions with the labor union, with a view to creating and securing employment.
