Akebono presently holds a 40% share of the OEM disc brake pad market in Japan and a 20% share worldwide. Through our development, production and sales bases we are building a global framework that encompasses Japan, North America, Europe and Asia. Launched on April 1, 2008, our updated medium-term management plan, "Akebono New Frontier 30," aims at capturing a 30% share of the worldwide disc brake pad market. Akebono is expanding its business with the objective of being a global company that is trusted by automotive manufacturers and end-users throughout the world.

In order to achieve growth as a trusted global company, we have established the Akebono Corporate Mission: through "Friction and Vibration, their Control and Analysis," we are determined to protect, grow and support every individual life. This mission gives direction to the broad range of Akebono's business activities. Further, encapsulated in the words "protect...every individual life" is the determination to safeguard not only people but also nature and the environment as a whole.

Guided by the Akebono Corporate Mission, each and every Group employee is expected to consider what contributions they can make to achieve these goals. To continue offering value, we believe that we must continue to follow the path to growth as a global company that is not only financially successful but also trusted by society.

In fiscal 2006 (ended March 31, 2007), we started corporate brand activities to encourage all employees to engage in heightening the appeal of the corporate brand and to thereby become a company that is chosen by customers all over the world—a company where employees can take pride in their work.

As January 1, 2008 marked the start of the Kyoto Protocol's five-year first commitment period, in fiscal 2007 Akebono undertook various activities as a company that delivers safety and security to society. The Companywide reduction of $\rm CO_2$ and volatile organic compound (VOC) emissions, the securing of *Kurumin* certification from the Ministry of Health, Labour and Welfare thanks to the Company's efforts to achieve a comfortable work environment for all employees and the supply of brake technology to the Vodafone McLaren Mercedes Formula 1 team are representative examples of these activities.

This has enabled us to take full advantage of the synergistic effects afforded through the maximum use of IT. The "Ai" in Ai-City refers to "Akebono Innovation" and "IT" (information technology). "Ai" is also the Japanese word for indigo blue, and refers to a textile dye unique to Hanyu-City, Japan where Ai-City is located.

Delivering a Higher Level of Safety as Brake Experts

The Akebono Group receives overwhelming support for its exceptionally safe and quiet yet responsive disc brake pads for automobiles, and Akebono's cutting-edge technology brings safety to countless people via its brakes for motorcycles and rolling stock. Moreover, we are steadily increasing performance in such fields as industrial machinery, including forklifts and wind turbine generators, and are nurturing a growing sensor business derived from control technology.


In fiscal 2007 (the year ended March 31, 2008), the Akebono Group posted record net sales and profit. Increased orders in both Japan and Indonesia underpinned a net sales improvement of ¥11.6 billion, or 6.7% over the previous fiscal year to ¥184.7 billion. Operating income rose ¥1.3 billion, or 9.2%, year on year to ¥15.2 billion owing to the effect of cost reductions. Net income was ¥6.6 billion, a slight increase of 0.1% from the previous fiscal year.

Enhancement of Corporate Governance as an Issue of Utmost Importance

Akebono undertakes a variety of initiatives to enhance corporate governance, an issue of the utmost importance to the company as it fulfills its corporate social responsibility. In April 2000, the Executive Officer System was implemented to separate executive duties from the management of the Company, to clarify responsibilities and authority, and to improve managerial efficiency. The Board of Directors is composed of ten Board Members, of whom two are External Directors in order to reflect an independent point of view. Furthermore, to ensure that management issues are fully addressed within the context of global management, we have adopted a system of prior deliberation wherein the Policy Council, Management Advisory Council and others deliberate upon relevant issues. Based on these deliberations, decisions are made and submitted to the Board of Directors for approval.

In addition to the risk management of each department and Group affiliate, the Risk Management Committee, chaired by the Representative Director & CEO, was formed to assess, manage and prevent risk throughout the whole Group. The Risk Management Committee establishes and executes countermeasure objectives for dealing with the most critical Companywide risks. Furthermore, to ensure internal and external oversight of business execution by management, we have put in place a three-part auditing system comprising the auditors, the independent auditor and the Internal Audit Office. In addition, external lawyers and certified public accountants provide direction and council on management issues as appropriate. Having put in place a corporate governance system, Akebono conducts transparent


and fair management from a global perspective as it strives to maximize corporate value.

Establishing a System of Internal Control

Internal control is a "system" within business processes preventing the occurrence of improprieties as a result of either action or failure to act. At a meeting of the Board of Directors held in May 2006, Akebono determined the "Basic Policy Regarding the Establishment of In-House Regulatory Systems." This resolution determined the systems to ensure that the execution of duties by the directors conforms to legal statutes as well as to the Articles of Incorporation and also to ensure appropriate work practices and risk management.

Furthermore, based on the Financial Instruments and Exchange Law, from the fiscal year commencing April 1, 2008, an internal control report with the date of record stated as the end of the fiscal year (March 31, 2009) will be submitted. The auditing of the internal control report will be conducted by an external auditing firm creating a practical system being deployed across the Group.

The objective of internal control is effective business performance, operational efficiency, the reliability of financial reporting, adherence to laws and regulations and the conservation of assets. To achieve these objectives, Akebono is now developing processes in its embrace of the concept of "Visualization" so that every issue, impediment and concern is identified, brought into the open and resolved in ways that encourage creative solutions to achieve cost reductions and improvements throughout the Company. Akebono is expanding its activities to appropriately manage these processes.



Compliance and Risk Management

Efforts to Spread Compliance Awareness



The Akebono Group believes that compliance is not limited to simply observing the letter of laws and regulations. We also recognize the need for employees to exercise good judgment in acting as responsible members of society by adhering to social customs and corporate ethics in both their work and private life.

Such standards for corporate behavior are gathered together with a code of conduct and other guidelines in the *Compliance Manual*. This manual was created to provide ongoing employee education, encourage sharing of information, and raise awareness.

We continue to promote the activities of the Compliance Committee, which we established in January 2003. The committee is chaired by a Senior Managing Executive Officer and Board Member, and General Managers of each department act as committee members.

General Compliance Meetings, which comprise regular members of the Compliance Committee, as well as compliance promotion officers, aim to raise compliance awareness by providing information and training to directors, auditors and employees.

Specific initiatives include training for employees, the monthly publication of *Compliance News*, posting compliance-related decisions on internal bulletin boards and the establishment of internal and external consultation services.

Akebono has established internal and external consultation services to deal with employees' questions, concerns and complaints. The services handle inquiries, including those made anonymously, from all Group employees including temporary and part-time employees. With this system we are able to identify and rectify issues at an early stage.

In September 2005, external consultation services were outsourced to a specialist external organization and the "Corporate Ethics and Work Environment Hotline" was launched.



The details of any inquiries and reports as well as personal information are kept confidential. To protect users of the consultation service from any prejudicial treatment, we have established internal rules to safeguard those who disclose information in the public interest. The Compliance Committee is mainly responsible for investigating reports and implementing remedial measures.

Efforts to Reduce Risk

Akebono considers the construction and maintenance of an appropriate risk management system to be an accurate response to the significant aspects of its commitment and responsibility toward society. In fiscal 2006 we therefore established the Risk Management Committee, chaired by the Representative Director & CEO. The Risk Management Committee identifies significant risks that may have a major impact on the business performance of the whole Group and assesses to what degree they could effect operations. In addition, each department and Group affiliate identifies risks in their own areas and takes action to reduce respective levels of risk. In fiscal 2007, we established a Risk Management Office charged with promoting Companywide awareness. The office held a total of 37 training sessions over the year, with 730 employees attending to gain a thorough awareness of risk management.

Information Security Activities

To adequately protect information assets, Akebono clarifies processes for handling each type of information. According to degree of risk and importance we protect customer data as well as internal system data from a variety of threats, including negligence, accidents, disasters and criminal activities. Akebono also ensures information security by raising awareness through education and training based on security rules. Such awareness is cultivated not only among the Board of Directors but also among employees across the Group, both in Japan and overseas. We regard information security as a matter of utmost importance and constantly improve a management system capable of adapting to a changing environment.

Environmental Mission

Based on our corporate mission statement, together with our Declaration for the 21st Century, we will continue to create new value into the 21st century. As a global corporate citizen, we also strive to protect the environment on a global basis and implement voluntary ongoing activities aimed at creating a safe, vibrant society that co-exists in harmony with the environment.

Basic Environmental Policy

- 1) We will actively implement initiatives that give consideration to safety and the environment from the development and design phase, and promote the development of technologies and products that minimize environmental impact.
- 2) Each and every employee will make ongoing efforts to reduce environmental impact to promote a recycling society by conserving energy and resources, reducing waste and carrying out recycling.
- 3) In addition to complying with environmental laws, regulations and agreements, we will endeavor to enhance our environmental management by establishing voluntary management standards both inside and outside Japan.
- 4) We will actively disclose information to increase understanding of our environmental initiatives and encourage positive relationships with communities with the aim of realizing a better living environment.

Highlights of Fiscal 2007 Activities

Efforts to Reduce CO₂ Emissions

In our efforts to create products that contribute to the reduction of CO₂, we developed brake calipers for automobiles that realize a 20% reduction in weight through the adoption of aluminum materials. Mass production of these calipers commenced in June 2007. In the non-automotive field, in fiscal 2007 Akebono's share of brakes and sintered disc brake linings equipped on bullet trains in Japan rose to approximately 50%.

Furthermore, together with promoting energy conservation at our production bases, at our Chubu Office located in Toyota-City, completed in March 2008, we deployed office heating and cooling systems that utilize underground water supplies in our efforts to reduce CO₂ generated by these offices.

Compliance with REACH Regulations

In April 2007, we established the REACH Working Group as an organization to foster compliance with REACH (Registration, Evaluation, Authorisation and restriction of Chemicals) regulations in Japan. In August 2007, a total of 110 people representing 81 of our suppliers attended our REACH Compliance Briefing, where an outline of REACH regulations and information on compliance initiatives were offered.

U.S.-based ABC Establishes Environmental Policy

Akebono undertakes numerous environmental activities at locations around the world. In July 2007, Akebono Brake Corporation (ABC) established the Akebono Brake Corporation Environmental Policy to protect the health of the people who manufacture and use our products, promote the success of the communities in which we work and live, and preserve the environment that we all share.

U.S.-based ABG Attains Master-Level Membership in KY EXCEL

As a result of voluntary environmental activities undertaken based on ISO14001 and KY EXCEL certifications (Kentucky Excellence in Environmental Leadership), in February 2008 Akebono Brake, Glasgow Plant (ABG) became the first company in Barren County, Kentucky, to have been selected for the KY EXCEL master level of membership.

ABG Executive Chosen as LEPC Chairman

The chairman of ABG's Environment and Safety Committee, Eric Swafford was selected as chairman of the Barren County Local Emergency Planning Committee (LEPC). In his two-year tenure as committee chairman, Swafford is responsible for ensuring adherence to obligations to report to local authorities on the use of hazardous chemicals by companies and to conduct activities that promote environmental reporting to the state government.

Akebono Brake (Thailand) Commences Operations

Having commenced operations in March 2008, Akebono Brake (Thailand) Co., Ltd. has, with the construction of facilities to treat drainage and exhaust emissions at different plants, met Thailand's environmental standards. Moreover, the company has devoted attention to the work environment, installing a fan blower equipped with mist extrusion equipment and lighting equipment that ensures a level of illumination surpassing criteria established by Thai authorities.



Product Life Cycle and Environmental Burden Mass Balance

Akebono's environmental efforts extend through every stage of the product life cycle, from development and design through the collection and recycling of used products. We put into practice the effective utilization of resources with the objective of forming a recycling society.

Development and Design

As an example of putting into practice effective utilization of resources to help protect the environment, Akebono Brake Iwatsuki Manufacturing, Co., Ltd. and Akebono Brake Yamagata Manufacturing Co., Ltd. have developed and designed proprietary initiatives that are working to reduce volatile organic compound (VOC) emissions.

Procurement

Akebono's efforts to protect the environment extend to our procurement policies, as demonstrated in January 2008 when we issued Guidelines for Akebono Purchasing Fair Business Practices.

Production

In fiscal 2007 we achieved a 100% recycling rate at consolidated production bases in Japan. We achieved reductions with regard to both CO₂ emissions, down 10.7% compared with fiscal 1990 levels, and water consumption, reduced 14.1%, from fiscal 2006. Moreover, we totally eliminated the use of hexavalent chromium from all production bases.


Overseas, due to the efforts of the Akebono Brake, Elizabethtown Plant (ABE), the volume of water required for cleansing operations was reduced from 7,000 gallons per day to 2,500 gallons. Additionally, by upgrading the capacitor bank of the electrical service entrance, we lowered electricity costs by \$9,580 for the year. In July 2007, hexavalent chromium was entirely eliminated from the zinc plating process.


At Akebono Europe S.A.S. (Arras), we reduced electricity consumption in fiscal 2007 by 21% compared to fiscal 2006, natural gas consumption was lowered 15%, and water consumption 21%.

Active throughout our global network, we introduced new initiatives in Suzhou, China to improve efficiency, reduce consumption and increase recycling.

Logistics

In Japan, improved shipping efficiency resulted in a 20% reduction of space required for Japan Railways (JR) container needs. Furthermore, by switching the manufacturing of drum brakes meant for the North American market to local production at ABE, long distance shipping from Japan was eliminated. Returnable containers for transport are now deployed for use in North America, Europe, Indonesia, China, Korea and Thailand.





Market Sales and Consumption

The rebuilt business for used brake shoes has been growing since 1965, and since 2005 has been augmented by the launch of the Akebono Eco Pads, a line of recycled brake pad products that continues to see expanded adoption in the Japanese aftermarket due to market trends toward recycling and Akebono's sales efforts to increase market share.



Akebono Eco Pads (Registered Trademark in Japan)


Highlights of Fiscal 2007 Activities


