Akebono Brake Organizational and Personnel Changes

TOKYO – Akebono Brake Industry Co., Ltd. announced organizational, executive and personnel changes to take effect January 1, 2008 to achieve its new medium-term management plan commencing April 2008.

Organizational changes by division

Automotive Sales Division

 Consolidation and reinforcement of the global sales structure is to be promoted through a Chief Engineer system in order to further enhance ties between R&D and sales functions.

Aftermarket Sales Division

- Assignment of personnel to new facilities in Nagoya (Akebono Brake Chubu
 Office) is to be intensified to further strengthen trust and relations with
 customers throughout the region.
- To promote region-specific strategies through reinforced ai-network activities, aftermarket component sales to independent distributors in Japan are to be administered by a separate department (Automotive Sales 3 Department), while strengthening the support structure for channels from sales agents to repair shops.
- To promptly identify overall aftermarket trends and developments, headquarters and regional sales offices are to be unified in a new structure based on thorough management by objectives to hasten decision-making processes.

Manufacturing Division

 An Optimal Production Implementation Department is to be established to strengthen follow-up functions for production preparation and optimize manufacturing activities.

- The Monozukuri Project (Manufacturing & HR Development Project) is to be reorganized and will include a Monozukuri Training Section to further promote the training and development of human resources.
- Tatebayashi Foundry is to be positioned within the Manufacturing Division and efforts continued to get operations underway.

Production Engineering Division

- Division of business activities is to proceed with the establishment of engineering sections specializing in the development of next-generation production methods and new technologies, as well as the creation of sections to provide technical support regarding production engineering at facilities worldwide for the ramping-up of new products and the standardization of manufacturing equipment.
- A Surface Treatment Development Section and a Control Section are to be created to reduce lead times for developing next-generation equipment through enhanced elemental engineering.

Quality Assurance Division

 An ISO & TS Audit Office and a Quality Audit Department are to be created as part of organizational reform to provide dedicated auditing functions.

Planning and administrative functions

- The Corporate Planning and Corporate Staff organizations are to be abolished at the divisional level, with responsibility for various planning and administrative functions assigned accordingly to executives.
- To create a structure that facilitates enhanced strategic development, the Human Resources Policy Planning Group is to be renamed the HR Development Department and will take over employment and HR database responsibilities from the Human Resources & Employee Relations Group, thus gathering these functions within the same department as HR management functions that have been primarily concerned with the cultivation and training of human resources.
- A Web Management Office is to be established.

Moreover, in accordance with the new organizational changes, the current

"group/team" structure is to be replaced with a "department/section" structure, including for Akebono Group affiliates.
