Akebono Brake Organizational and Personnel Changes

TOKYO – Akebono Brake Industry Co., Ltd. announced organizational and personnel changes to take effect on September 1, 2025.

On Thursday, August 7, we announced our medium-term business plan (FY2025 to FY2027). This medium-term business plan is based on a foundation of strengthening Safety, Quality, and Compliance to become a company that continues to earn the trust of its customers and stakeholders. The four pillars of this plan are "Ensure profitability in each region, with a focus on achieving profitability in the United States," "Reform of Cost Structure," "Implement initiatives for immediate expansion of sales," and "Focus on new technologies, new products, and new markets for the next medium-term business plan." Through these initiatives, we aim to rebuild our foundations and target an operating profit of 8 billion yen (operating profit margin of 6%) by the FY2027.

Organizational and personnel changes aimed at achieving this medium-term business plan will be implemented on September 1 as outlined below.

· Compliance

To strengthen compliance, a Corporate Governance Office will be newly established under the CEO. It will oversee legal functions and internal control. The CEO will be responsible for internal control.

· Safety and Quality

To strengthen safety and quality systems, an Executive Officer in charge of Safety & Quality will be appointed.

Controlling Division

To reform cost structure, the organizational structure will be thoroughly revised with the aim of strengthening cost management and profitability management functions.

· Research & Development Division

R&D planning functions will be strengthened in line with our medium-term business plan, advanced development functions will be integrated, and we will shift from the current nine-department structure to an eight-department structure.

· Regional Operations (Outside Japan)

To achieve profitability in North America, we will establish a management structure in the North American region and strengthen our management structure in Asia.
